# CLUB RULES

## 1.Name

The name of the club shall be Windsor Cricket Club.

## 2.Colours

The colours of the club shall be red and green.

## 3. Objectives

The club is formed for the purpose of playing cricket and for the provision of the necessary facilities for the game. Membership is open to any person subject to the agreement of the general committee and payment of the appropriate subscription.

## 4. Subscription

i) The annual subscription fee will be agreed at the AGM for each of the following groups:-

- a) Adult paying members (with discount allowed if paid before first Thames Valley League game).
- b) Adult playing members who are in full-time education.
- c) Non-playing members.
- d) Youth playing members Under 18 (those in full-time education and under 18 on October 1st).
- e) Youth playing members Under 15.
- f) Associate football members (those only eligible for the use of the football facilities).

ii) Discretionary fees may be available in some circumstances on application to the general committee.

iii) All members paying a subscription within the provisions of sub-clause i) (a - d) hereof and vice-presidents and life members shall be deemed to be full members of the club. Only full members are entitled to vote at any general meeting of the club.

iv) The selection committee shall have the right to reduce the subscription in the case of persons joining the club for a limited period or mid-season, provided payment is made in advance and such reduction shall not be greater than the pro rata proportion attributable to the non-playing period.

v) Except as provided for in para vi) hereafter, any member whose subscription is not fully paid by June 30th shall not be considered for selection until the subscription is received.

vi) a) Newly elected members must pay their subscription in full within 14 days of being elected. b) Established members not becoming available until after June 15th must pay their subscription in full within 14 days of the date they are first available to play.

- c) No person shall be admitted to membership, or be admitted as a candidate for membership to any of the privileges of membership, without an interval of at least two days between nomination or application for membership and admission, nor may any person becoming a member without prior nomination or application be admitted to the privileges of membership without an interval of at least two days between becoming a member and admission.

d) Each member shall be entitled to introduce no more than three guests at any one time.

## 5.Match Fee

A match fee incorporating tea money and material expenses will be payable by all playing members. The level of the match fee shall be set each year by the general committee. The amount payable by youth playing members and full-time students shall be half the figure for adult playing members. Discretionary fees may be available in some circumstances on application to the general committee. The match fee for football matches will also be agreed by the committee. It will be a two-tier system with a lower fee for adult (cricket) playing members, and a higher one for associate football members. The extra cost of the associate member's match fee shall be at least enough, over the course of the season, to fund the difference between associate and full membership.

## 6. Officers

i) The officers of the club shall be elected at the AGM and shall consist of the president(s), vice-presidents, chairman, vice-chairman, club captain, trustee(s), treasurer, auditor(s), secretary, fixture secretary, bar manager, colts manager, pavilions secretary, social secretary, kit secretary, commercial secretary, club captain (Sunday), records officer, welfare officer, development officer, captains and vice-captains of each eleven and any other officer deemed necessary.

ii) Proposals for life membership and vice-presidency may only be made to the AGM by the general committee.

iii) The office of President of the Club is to be held for two years only and not for consecutive years.

## 7. Management

i) The management of the club shall be in the hands of the general committee. The general committee shall consist of the president(s), chairman, vice-chairman, club captain, treasurer, secretary, fixture secretary, bar manager, social secretary, colts manager, pavilions secretary, welfare officer, development officer and the club captain (Sunday). The general committee shall also have the power to co-opt as necessary.

ii) Five members shall form a quorum and all committee decisions are made on a simple majority vote, i.e. over half the committee present must vote for a motion for it to be passed.

iii) The general committee shall meet not less than five times per annum.

iv) The general committee shall have full power to act on behalf of the club in the case of an emergency or any other circumstances not covered by the rules.

v) The general committee shall appoint a wine (bar) subcommittee for the purpose of managing the purchase and supply, by resale to members in the club house belonging to the club, of intoxicating liquor. The wine subcommittee shall consist of two or more of the elected members of the general committee.

## 8. Selection Committee

Selection will be carried out at weekly meetings by the selection committee. The selection committee shall consist of all team captains, vice-captains, a colts' representative (appointed by the colts' manager) and the club captain. The latter shall have the final say in disputes over selection. Any member selected to play and finding himself unable to do so shall notify his team captain at least 36 hours prior to the said match. Any member failing to give such notice without due cause may be suspended from playing for up to two weeks. The player has the right to a hearing at the next selection meeting if he so desires.

## 9. Meetings of Members

i) An AGM of all members shall be held on the third Thursday in January each year and shall transact the following business:-

a) Receive the report of the general committee.

b) Receive the audited statement of accounts for the year. (The year being 1st January to 31st December.)

c) Elect officers and other members of the general committee.

d) Agree the level of annual subscriptions.

e) Consider any special business of which due notice has been given in accordance with 9(ii)

ii) Notice of any special business for the AGM (signed by two members) shall be sent to the honorary secretary not later than 28 days before the date of any such meeting.

iii) At the AGM, 20 members shall form a quorum. The club's officers, playing members, (including colts of 15 years and over) and non-playing members (as per rule 4 iii) shall be entitled to vote.

iv) Special general meetings of the members may be called at any time by resolution of the general committee or by the secretary within 6 weeks of the receipt of a request signed by not less than 12 club members setting forth the business for which such a meeting is desired.

v) Notice of general meetings, together with details of any special business to be transacted, shall be sent to all members at least 14 days before the date on which the meeting is to be held.

vi) At no time will non-voting members exceed 15% of the total membership.

# Club Rules cont.

## 10. Discipline

The committee shall have the power to expel any member who shall offend against the rules of the club or whose conduct shall, in the opinion of the committee, render him/her unfit for membership. Before any member is expelled the secretary shall give him/her at least 7 days notice to attend a meeting of the committee. This notice shall contain particulars of the complaint made against him/her. No member may be expelled without first having the opportunity of appearing before the committee to answer the complaints made against them. The general committee shall also have the power to discipline any member as it sees fit.

## 11. \*Club Guests

i) Any member shall be entitled to introduce guests to the club provided that the prospective guest has not been expelled from the club or had a membership application denied. The member introducing a guest shall enter the name and address of the guest together with their own name in a book which shall be kept for that purpose in the clubhouse.

ii) Visiting teams and officials may use the club facilities but are not allowed to buy intoxicants unless signed in as bona fide guests.

iii) Off sales will only be made to bona fide members and will only be provided in an enclosed vessel and supplied only within licensing hours.

## 12. \*Strangers

i) In accordance with the Licensing Act Section 49 (1) the clubhouse may be hired out to an outside organisation on no more than 12 occasions per year.

ii) There may be admitted to the registered premises of the club, persons other than members and guests subject to any conditions which may be imposed by the licensing justices for the Royal Borough of Windsor and Maidenhead. Intoxicating liquor may be sold to them on behalf of the club for consumption on the premises and not elsewhere.

## 13. \*Clubhouse(s) - Intoxicating Liquor (permitted hours)

The permitted hours for the sale of intoxicating liquor to persons aged 18 and over shall be exactly as described by the current licensing laws.

Opening hours: 11a.m. - 11.30p.m. Monday to Saturday

12 noon - 10.30p.m. Sundays

## 14. Amendments to Rules

Any proposed alteration to these rules must be made in writing to the secretary by 1st September so that the proposal may be displayed on the club notice board. **This will each year include the committee's recommendation for subscriptions for the following season.** Any member wishing to propose a further amendment to any proposal described above must do so in writing to the secretary by 20th October. No alteration or addition to these rules shall be made except by a resolution passed by a majority of members present at an AGM of the Club, prior notice of which must have been given as per rule 9 i) e). \*Rules 11, 12 and 13 apply only to the former Windsor & Eton CC Clubhouse.

## WINDSOR CRICKET CLUB MEMBERS 'Code of Conduct'

Windsor Cricket Club is fully committed to safe guarding and promoting the well being of all its members and has recently adopted the ECB 'Safe Hands- cricket's policy for safeguarding children' guidelines. The Club believes that each member (seniors/ colts/ coaches/ parents/ volunteers and social members) should abide by the ECB 'code of conduct and spirit of cricket' guidelines. In addition to this the club also expects its members to follow the following guidelines:

### All Club members:

- All members are to respect the rights and dignity of every person, and will treat everyone equally regardless of age, gender, race, ethnicity, religious beliefs, sexuality or social/economic status.
- The club is committed to everyone being able to enjoy contributing or playing cricket in an environment free from intimidation, harassment or abuse.
- All Members must respect opponents and visitors to the club.
- All Members must pay annual subs, net fees and social events promptly without having to be continually chased.

### All Playing Members:

- All players must respect the officials and their decisions, and must never condone rule violations or argue with officials.
- All players visiting other clubs (in normal fixtures or on tour) must remember they are club ambassadors and are representing the whole of WCC and must act in an appropriate manner.
- Players are expected to pay their match fee in full on the day of the game and not leave the ground before paying.
- Players are expected to keep agreed meet times and must inform their captain as early as possible by phone of lateness or absence. If a player puts a 'P' on the team sheet they must inform their captain on Monday if they are available the following weekend.
- When a player is promoted or dropped from a particular side, the captain of the team that they are leaving will call them first. (If a player is unavailable for 1 or more weeks, they will only get a call from the captain they will be playing for that coming Saturday).
- Players are expected to arrive 10mins before the meet time, to enable the whole team to leave on time. Any player late 3 times out of 5 will be noted and this may influence selection meetings.
- All 11 players are expected to do pre and post match pavilion and ground admin. It is not acceptable to leave admin to a few people every week. It is a team game and all players need to pull their weight to make match day happen as smoothly as possible. The earlier you arrive the easier the admin task you get!
- The team's playing at home are expected to help in the bar after the game, by serving behind the bar and collecting glasses.
- Playing Kit- for 1st and 2nd XI Sat and 1st XI Sun:

Players in these teams are expected to wear a WCC shirt (and a WCC jumper if needed). If they cannot buy or get hold of a WCC shirt or jumper, only plain white shirts and jumpers are to be worn, other club shirts and jumpers should not be worn. If players are going to wear a cap it should be a WCC cap only. If wearing a sun hat, a plain one is preferred over another clubs colours.

### Colts Members:

- Colt memberships are taken at the beginning of winter nets and cover the cost of nets, insurance, coaching and match fees for that season.
- Colts are expected to turn up to nets in suitable clothing and footwear.
- Junior members are not allowed to consume alcohol or drugs of any kind on the club premises or whilst representing the club.

## WINDSOR CRICKET CLUB MEMBERS 'Code of Conduct' cont.

### Coaches/ Team Managers/ Captains:

- Consider the wellbeing and safety of participants before anything else.
- Adhere to the 'job description' for their role and responsibility in the club.
- Develop an appropriate working relationship with participants/members based on mutual trust and respect.
- Make sure all activities are appropriate to the age, ability and experience of those taking part.
- Promote the positive aspects of cricket (e.g. fair play)
- Never exert undue influence over participants to obtain personal benefit or reward.
- Never condone rule violations, rough play or the use of prohibited substances.
- Encourage participants to value their/the team's performances and not just results.
- Encourage and guide participants to accept responsibility for their own performance and behaviour.

### Parents and Volunteers:

- Encourage their children to learn the rules and play within them.
- Discourage unfair play and arguing with the officials.
- Help their children to recognise good performance, not just results.
- Set a good example by recognising fair play and applauding good performances of all.
- Never punish or belittle a child for losing or making mistakes.
- Publicly accept officials' judgements.
- Use correct and proper language at all times.
- Set a good example by recognising fair play and applauding the good performances of all.

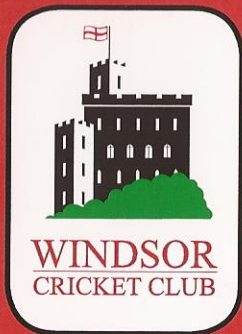
